Manitoba Artistic Swimming Club Grant aids remote clubs with their High Performance Development Initiatives, in lieu of being able to attend all centralized PTSO initiatives.

MAS will require Clubs to provide a post-grant report outlining how the funds were spent by **April 30th, 2022,** upon request of the MAS Executive Director. If the funds are not yet completely spent, Clubs will be expected to report what their plans are at this time.

Failure to participate satisfactorily in this reporting process could negatively affect your Club's funding allocation in the next fiscal year.

MAS REMOTE CLUB HP GRANT Summary

This grant is available to remote clubs to be used to support High Performance activities for the Train to Compete, Learn to Win and Perform to Win stages of the LTAD (Long Term Athlete Development) Plan.

Eligible activities include competitive athlete clinics or camps; coaching development (courses, clinics, travel, manuals); and honoraria for specialist coaches/clinicians. Upon request of the MAS Executive Director, clubs are expected to provide a summary of their activities (or planned activities) in this area, including actual numbers of participants.

The club is responsible for all aspects of their proposed activities, including booking pool time (or hosting during their own practice time), contracting the coach and/or facilitator trained in High Performance activities.

The MAS Remote Club Grant is up to a maximum of \$1500 and will be offered annually. All participants must be registered members with Canada Artistic Swimming (CAS) and Manitoba Artistic Swimming (MAS).

Applications must include a detailed budget of projected expenses and revenues.

Items that may be covered include the following:

- pool space rental – based on approximately 6-8 swimmers per lane
- coaching fees (provide supporting documentation)
- administrative costs – please describe.
